

Board Meeting Minutes

May 11, 2021

A meeting of the Alabama Board for Registration of Architects was held on Tuesday, May 11, 2021 at 10:00 a.m. at the RSA Union Building, 100 North Union Street, Montgomery, Alabama 36104.

Members Present: Michael L. Chapman, Chair; Nolanda Hatcher, Vice-Chair; Jimmy H. Seay, Jr., Member; Daniel D. Bennett, Member; Emily Coe, Member; and Sted McCollough, Member.

Ex-Officio Member: Scott Pilgreen, State Fire Marshal.

Staff: Paula Pilgreen, Executive Director; Debbie Whitman, Operations Manager; and John Selden, Assistant Attorney General.

Chair Chapman called the meeting to order at 10:10 a.m. and declared that a quorum was present in the following Members: Mr. Bennett; Ms. Hatcher; Mr. Seay; Mr. McCollough; Ms. Coe, and Chair Chapman.

The meeting was advertised on the Secretary of State's website and the Board's website in accordance with the Open Meetings Act.

Motion 2021-18: Mr. Seay moved that the Consent Agenda, including the Minutes from the February 25, 2021 Board Meeting, be approved as presented. Ms. Hatcher seconded. Motion carried with all in favor (Mr. Seay, Mr. Bennett, Ms. Hatcher, Ms. Coe, Mr. McCollough, and Chair Chapman).

Ms. Whitman administered the Oath of Office to the three (3) reappointed Board Members: Michael L. Chapman, Nolanda Hatcher, and Sted McCollough.

Motion 2021-19: Mr. Bennett moved that the Board approve payment to Auburn of \$2,100.00 to pay for NCARB records for new architectural students, and payment to Auburn of \$2,210.00 for NCARB spring renewal records for architectural students. Mr. Seay seconded. Motion carried with all in favor (Mr. Seay, Mr. Bennett, Ms. Hatcher, Ms. Coe, Mr. McCollough, and Chair Chapman).

Motion 2021-20: Mr. Seay moved that the Board approve the two (2) proposed regulations (100-X-2-.02 and 100-X-2-.10) as advertised having received no public comments. Mr. Bennett seconded. Motion carried with all in favor (Mr. Seay, Mr. Bennett, Ms. Hatcher, Ms. Coe, Mr. McCollough, and Chair Chapman).

Motion 2021-21: Mr. Bennett moved that the Board compose a letter to Governor Kay Ivey urging her to veto HB220 since the Board does not support the bill because it is

contrary to the health, safety, and welfare of the public. Ms. Hatcher seconded. Motion carried with all in favor (Mr. Seay, Mr. Bennett, Ms. Hatcher, Ms. Coe, Mr. McCollough, and Chair Chapman).

Motion 2021-22: Mr. Seay moved that the Board examine the possibility of moving the November 2021 meeting up to October 14th or 15th, 2021, to coincide with the Alabama AIA conference being held at the Gulf Lodge Hotel, Gulf Shores, Alabama, October 15th - 16th 2021. Mr. Bennett Seconded. Motion carried with all in favor (Mr. Seay, Mr. Bennett, Ms. Hatcher, Ms. Coe, Mr. McCollough, and Chair Chapman).

Motion 2021-23: The time being 11:10 a.m. and there being no further business, Ms. Hatcher moved to adjourn the meeting. Mr. Seay seconded. Motion carried with all in favor (Mr. Seay, Ms. Hatcher, Mr. McCollough, Ms. Coe, Mr. Bennett, and Chair Chapman).

Chair Chapman announced that the next currently scheduled meeting would be held on August 11, 2021 in Montgomery, Alabama.
